# **Key Qualifications**

Holds a Ph.D. in Economics, specializing in health economics, population economics, human resource economics, and development economics, with years of extensive professional experience in the fields of health and population/family planning policy, gender mainstreaming, health care financing, health information system, monitoring and evaluation of population, health and government economic and social programs, and local governance for health.

Worked with various government agencies at highest management levels in policy development, program and project assessments, and capacity building. In 1986, helped establish the Health Economics Program at the School, sought funding support from national and international organizations, undertook health policy research, and engaged in policy development, particularly with the Department of Health. Several occasions during the period, served as Chair of the Department of Economics and Director for Finance for the School of Economics, UPecon Foundation, and the Philippine Center for Economic Development.

1987-1989, University of the Philippines Center for Integrative and Development Studies (UPCIDS) Project Director of multidisciplinary research project entitled "Population, Human Resources and Development" supported by the United Nations Population Fund (UNFPA) involving social scientists from the University of the Philippines System. Published extensively on population and development, monitoring coverage of public programs on the poor, and monitoring and evaluation.

This component undertook health policy research, conducted training in health economics and health financing, developed the Philippine National Health Accounts (PNHA), and established a Multi-Sectoral Health Forum for discussion of policy issues among a wide range of stakeholders. The first set of PNHA estimates made for 1991-1994 formed the basis for policy discussion in Congress that led to the eventual passage of the National Health Insurance Act of 1995. Published health sector reviews and framework on health policy development.

In 1999, worked with the Commission on Population and the Futures Group International to develop a framework for strengthening the Philippine Population Program by explicitly clarifying the fertility and family planning objectives of the Program and emphasizing the role of government in fertility reduction and provision of family planning services. Such a framework was subsequently adopted by POPCOM and incorporated in the Directional Plan for the Philippine Population Management Program 2001-2004
